

ENERGY AND CLIMATE

Growing the development and use of clean energy in Iowa while phasing out fossil fuels was the focus of IEC's energy work in 2021. The Council officially announced a goal for Iowa to reach 24/7 100% clean electricity generation by 2035. "Achieving 100 percent clean power in Iowa by 2035 is achievable and is the critical first step for Iowa to do its part in addressing climate change," said executive director Brian Campbell. While the organization has long advocated for the growth and use of clean energy, setting an official target sends a message to critical stakeholders and allows the organization to more effectively coordinate campaigns, such as electrification of buildings and transportation, renewable energy development, and the retirement of fossil fuel electricity generation.

IEC increased efforts in 2021 to close the remainder of Iowa's coal power plants. The council and partners generated a steady release of information that shed light on utilities' harmful and wasteful coal power generation.

IEC joined with partners in suing the Iowa Utilities Board, arguing that coal plant retirement should be considered in utility plans to manage emissions. *Expert* <u>analysis</u> from Synapse Energy Economics concluded that replacing Iowa's coal plants with renewable generation would provide reliable electricity while saving customers a minimum of \$1.2 billion, while our <u>Iowa Electric Generation: 2021</u> <u>Condition of the State</u> report clearly measured the harms to public health and corn yields for coal-fired generation in our state.

In October, an <u>IEC-commissioned study</u> by Iowa State University Extension illustrated the economic risks for coal plant communities if not given sufficient time to prepare for closure. IEC called on MidAmerican Energy to announce intended retirements for its six Iowa coal plants to help the communities of Council Bluffs, Ottumwa, Muscatine, and Sioux City plan ahead.

IEC and a growing coalition continue to pressure MidAmerican Energy to retire its coal plants by 2030 to reduce health and economic impacts and meet critical climate goals. One such action helping to drive this issue is individual communities adopting 24/7 clean energy goals. <u>Des Moines</u> adopted what is believed to the be the first-of-its-kind resolution in January 2021, making it a climate leader. IEC worked in the second half of the year with the cities of Waterloo and Iowa City, which the Council hopes will adopt similar resolutions in 2022.

CLEAN WATER AND LAND STEWARDSHIP

lowa's soil and water quality issues are long-documented and well known. While plenty of lip service has been paid to how important clean water is to all lowans, the quality of our lakes, rivers, and drinking water sources keeps getting worse. In 2021, IEC focused on providing clear and reasonable policy solutions to improve water quality and accelerate land use change in lowa.

Our <u>Policy Solutions to Actually Reduce Nutrient Pollution in Iowa's Water</u> updated implementation timelines for the Iowa Nutrient Reduction Strategy – still 85+ years – and offered five straightforward recommendations, such as creating an individual duty to protect surface water, adopting numeric nutrient criteria, and funding the Natural Resources and Outdoor Recreation Trust Fund (also known as IWILL).

IEC led the way in launching a new coalition to fund IWILL in 2021. The new <u>Fund the Trust</u> coalition is a multi-year project to successfully implement a sales tax increase to deliver millions of dollars in supplemental funding for lowa's natural resources and outdoor recreation. Throughout the year, the Council engaged in publications and activities to improve drinking water service and safety across the state. The <u>Rural Water Systems in Iowa</u> report illustrated the challenges and opportunities facing the state's rural water systems. In August 2021, IEC submitted a petition to the Iowa Department of Natural Resources to update animal feeding operation siting rules, with a goal of improving groundwater protection and providing safer drinking water for communities and private well owners.

Drinking water and natural flood infrastructure remain a focus for IEC's water and land program in the coming year, as the organization continues to draw support for this work from a growing number of funders and partners.

JUSTICE, EQUITY, DIVERSITY, AND INCLUSION

Following our commitment to action in 2020, IEC staff developed and implemented an action plan to incorporate justice, equity, diversity and inclusion (JEDI) focus areas into existing program and administrative work. Such initiatives include staff trainings and conversations, intentionally seeking out diverse vendors and performers for events, ensuring IEC materials reflect more diverse representation, inviting new voices to speak and share insights with IEC and our partners, and more.

IEC staff quickly put these ideas into action. IEC hosted guest speakers for staff and member organizations on the topics of environmental justice to expand our reach to new communities. We supported or sponsored new events, including the Latino Film Festival in Des Moines and Proteus' I'm Thankful for a Farmworker fundraiser. IEC has eagerly engaged in conversation about environmental justice in Iowa, including IEC's energy program director Kerri Johannsen participating on a Gazette panel on energy equity, and executive director Brian Campbell's Earth Day keynote at the University of Iowa, focused on environmental justice.

Our events in 2021 featured guest speakers and award winners working on a variety of justice and equity issues, including our <u>Bright Ideas</u> keynote Destenie Nock on the topic of energy equity and the 100% Iowa webinar on <u>Energy</u> <u>Resiliency and Justice</u>. Award winners included individuals doing work with frontline and underserved communities. We welcomed several guest blog posts and panelists discussing issues of environmental justice, recreation, and water quality.

As IEC and our coalition strives to grow and serve a changing state, we're engaging in new environmental justice partnerships. Together, we are working to build a stronger community, create valuable connections, and make lowa a better place to live, work, and explore for ALL lowans.

COMMUNICATIONS AND OUTREACH

IEC news and information reached more lowans in 2021, expanding our audience through engaging content. 100% lowa launched <u>Current State</u>, delivering energy news and information to subscribers monthly. IEC successfully expanded the popular <u>Weekly Water Watch</u> to a monthly e-newsletter in the winter months. IEC now sends seven e-newsletters to our growing list of subscribers, totaling more than 12,500 individuals.

Social media continues to grow the Council's community, with the addition of YouTube and LinkedIn in 2021. By the end of the year, nearly 15,000 people followed IEC across our six social media accounts. Find us online and join the community!

IEC sought out new venues to engage new audiences in 2021. The organization was selected to host a table and craft for the first time at the popular Des Moines Arts Festival in June. The Council tabled and sponsored the Latino Film Festival in Des Moines and tabled at the August Floatzilla event in the Quad Cities.

The Council continues to be a respected resource for journalists, even as the media landscape evolves. IEC was featured or included in nearly 200 news and media pieces across 90 platforms in 2021, providing important science-based data and stories about environmental issues in Iowa. IEC will continue to live up to our reputation as a trusted and knowledgeable source, building beneficial relationships with new and seasoned communicators.

FUNDRAISING

IEC expanded on the lessons learned and relationships built in 2020 to deliver another successful year of fundraising for the organization. We celebrated the return to limited in-person events by hosting hybrid fundraisers with satellite locations around Iowa for Pro H2O and Bright Ideas. We launched new events, including our inaugural Environmental Mixology, several house parties hosted by members and supporters, and even a solo album launch party with Jason Walsmith of the Nadas!

We welcomed new partners in 2021. Iowa West Foundation supported IEC's work with flood-ravaged communities in western Iowa, educating and engaging with community leaders and members on natural flood mitigation strategies and implementation of these solutions in their communities. Big Grove Brewery and Green State Credit Union selected IEC as the non-profit partner for their Big Grove for Good campaign. The fall release of their Greener State of Mind craft brew brought attention to water quality issues across Iowa and thousands of dollars in funds for IEC's clean water work.

On August 4, IEC and coalition partners launched the new Iowa Gives Green statewide day of giving. 17 environmental nonprofits participated, raising more than \$25,000 in the inaugural year. More organizations have expressed interest in joining for the 2022 Iowa Gives Green day on August 3.


FINANCIAL OVERVIEW

The Iowa Environmental Council is a 501(c)(3) nonprofit, nongovernmental organization. Our work is supported by our members, individual and corporate gifts, and grants.

IEC's fundraising efforts grew significantly in 2021. Thanks to hybrid fundraising events, the addition of new programs and partnerships, expanded fundraising mailings, and a growing supporter pool, IEC's total number of donors increased by more than 300 people in 2021. This growth is reflected in the 2021 revenue report below, with fundraising and events raising \$43,000 more than 2020, while the categories of grants and program specific revenue also grew.




